In continuation of earlier BI Office Order vide no. 4.	Charges of using of 2nos. of Lecture Hall of Unified Academic Campus, Salt lake	30,000/- (Rupees thirty thousand only)	25,000/- (Rupees twenty five thousand only)
5.	Charges for using of 1 no. of Lecture Hall of Unified Academic Campus, Salt lake	20,000/- (Rupees twenty thousand only)	15,000/- (Rupees fifteen thousand only)

All the booking needs to be done 30 days in advance. 100% booking charges for Auditorium along with GST (as applicable) should be deposited in Bose Institute account in advance within 7 working days from the issuance of the booking order.
