2. IAEC / Ethical clearance certificate of the research project of the respective Institute / Organizations, willing to purchase different animals species.
3. A copy of CPCSEA Registration certificate of the Animal House facility of the said Institute / Organizations.
4. A declaration to the effect that the animals procured will be used for research purposes only by the said Institute / Organizations.
5. A declaration to the effect that the animals procured by the concerned organization will not be sold / sublet to any other organizations / Institutes.

All the above documents will be submitted to the Administration / Accounts Section for approval by the Competent Authority, Bose Institute and thereafter Invoice in favour of respective Institutes / Organizations for selling of the animals will be generated by the Accounts Section. Only



