INSTRUCTIONS TO CANDIDATES:

1. Up-to-date curriculum vitae of the applicant should be submitted as an attachment (as **pdf file** only) with the **online application** form so as to reach by 12-08-2013 till 15.00 hrs. (IST).
2. Only applications received online will be processed. Candidate should send the hard copy of the online application (with applicant's code which will be generated only after submitting the application) along with attested copies of all certificates and testimonials so as to reach by 19-08-2013 till 15.00 hrs.(IST).
3. The System will not accept any application after 15.00 hrs. (IST) on 12-08-2013.
4. Copies of Certificates/ Testimonials need not be attached at this stage with the online application.

5. Eligibility criteria including the upper age limit will be reckoned on the last date of submission of application, i.e., on 12-08-2013.
6. The short-listed candidates will be intimated the date of interview at their respective email IDs. The list will also be available in this website. No individual letter to the candidates will be sent.
7. Before applying, the applicants should ensure that they possess at least the essential qualifications laid down for the post and other conditions stipulated in the advertisement. If a candidate is found not eligible, his candidature will be cancelled at any stage of the recruitment. (It may be noted that even if a candidate qualifies in the interview and subsequently it is found that he does not fulfill the eligibility criteria, his candidature will be cancelled).
8. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle a candidate to be called for interview. In the event of number of applications being large, the Institute will resort to short listing criteria to restrict the number of candidates to be called for interview.
9. The interested and eligible candidates may keep a watch at this site for any amendment.
10. Candidates working in Government/ Semi Government/ PSU/ Autonomous Bodies etc. should send the hard copy through proper channel and shall also produce No Objection Certificate at the time of interview, if called for.

Those who are called for interview should bring one print copy of this application duly signed and affixing a recent passport size photograph along with original & photocopies of certificates and testimonials and a standard ID Proof.
15. For each application, one unique Applicant Number will be generated. Therefore, candidates are advised to apply only once. They are also advised not to press the back/refresh buttons during online application.
