Bose Institute was founded by Acharya Jagadis Chandra Bose in 1917 for advancement of science and dissemination of knowledge. The Institute, celebrating its Centenary year, has served the nation since its inception in both Physical and Life Sciences having six campuses in and around Kolkata and one at Darjeeling.

Bose Institute, Kolkata, invites applications/nominations from highly motivated and dynamic scientists/academicians of eminence for the post of Director, who should be an Indian National. The ideal candidate will be a dynamic leader with substantial experience and achievements in the field of Physical or Life Science with a clear vision for an institution dedicated to these areas of research.

The Director will be appointed after obtaining the approval of the Competent Authority based on the recommendations made by a high-level Search-cum-Selection Committee. The Search-cum-Selection Committee will consider received in response to this advertisement as well as nominations received from eminent academic persons like Fellows of National Science Academies, Directors of National Laboratories, Vice Chancellors of Universities etc.

The Committee can consider those who may not have applied for the post after considering all the applications and nominations and finding that no candidate is suitable.

The Search-cum-Selection Committee can also invite a person of high repute for appointment.

The Ministry/Search-cum-Selection Committee would formulate transparent criteria for short listing of candidates and for the subsequent selection.

On the recommendation of the Search-cum-Selection Committee, the appointment of the candidate shall be made by the Governing Body with the approval/concurrence of Central Govt. (Deptt. of Science and Technology) and Appointments Committee of the Cabinet (ACC) wherever applicable.

(1) Name of the post: Director

(2) Classification: Scientific

(3) Pay Scale: Rs. 67,000 (annual increment @ 3%) -79,000/-

(4) Mode of recruitment:

Recruitment for the post of Director shall be made by any of the following method(s):

(a) By Direct Recruitment

(b) By Deputation, including short-term contract

(c) Re-employment

- (5) Tenure for Direct Recruitment & Deputation/Short-term Contract: 3 to 5 years or on attaining the age of superannuation as per extant Govt, instructions (60 years at present) whichever is earlier.
- (6) Probation period: One (01) year.
- (7) Age limit: Not exceeding 56 years of age. The crucial date for determining the age limit shall be 1 January of the calendar year if the post is advertised in the 1s half of the calendar year or 1s July of the year if the post is advertised in the 2st half of the calendar year.

(b) Possessing the essential educational qualifications mentioned in qualification and experience of mentioned in point 7 & 8 above.
