3. <u>Terms and conditions:</u>

- i. Prices should include the price for the item inclusive of transportation cost, taxes, levies, duties, GST, etc. All rates quoted should be of basic price of the equipment/instrument **inclusive** of all taxes, levies and duties. The rates should be quoted both in figures and words. **Request for inclusion of any tax/levy at later stage will not be entertained.**
- ii. Transportation, Packing, Forwarding and Insurance Charges, installation and demonstration / training charge (if any), to be charged should be inclusive of the item price.
- iii. Prices quoted should include warranty period of one (01) year from the date of supply/installation for all items quoted including their associated instrumentation.
- iv. 60% payment may be released only after successful supply of materials at site. Remaining will be released after successful installation and commissioning of items. The Tender fee of Rupees (Non-Refundable) must be submitted in a separate demand draft.
- v. Director, Bose Institute reserves the right to accept or reject any or all tenders either in part or in full. The reasons for rejecting the tender of a prospective bidder may be disclosed only when enquiries are made.
- vi. Bills in Triplicate should be presented for payment within 15 days of supply/completion of work.

- vii. The Order no. is to be noted on both challan and Bill.
- viii. All bills are to be accompanied by order copies and challans as received.
- ix. Payment will be made within 60 days of Submission of proper bills; challans etc. by A/c payee cheque or NEFT, no cash payment will be made under any circumstances.
- x. Bidder shall furnish an undertaking for providing Comprehensive onsite warranty for any manufacturing defect for a period of <u>one</u> year against each item from the date of supply/installation on their letter head, failing which, their offer will not be considered.
- xi. SELECTION WILL BE MADE PURELY ON ESSENTIAL TECHNICAL DOCUMENTS. The authority will evaluate and compare the quotations (the gross amount i.e. inclusive of all taxes, other charges etc.) determined to be substantially responsive i.e. which- (a) meet the qualification criteria specified in the tender, (b) Are properly signed, and (C) Conform to the terms and conditions, specifications without deviations.
- xii. Only one best quality item (according to our specification) should be quoted against each item. On no account should different qualities e.g. A, B, & C of items be quoted. Those items that have been quoted as per different qualities (In contravention to the specifications) will not be considered at all and will be summarily rejected.
- xiii. Based on our specifications, image/drawing of item to be provided and Model Name/No. (if applicable) and Brand must be clearly mentioned in the quotation, without which quotation will not be considered.
- xiv. In case of non- supply of material within the due date i.e. within the date of delivery, the authority will have the right to impose penalty like forfeiture of performance security and removal of the name from the list of the vendor and resort to risk purchase in full or part thereof at his/her discretion, his/her decision shall be final and bind.
- Xv. Original Manufacturer/firm must have manufacturing facility certified by ISO 9001:2015 14001:2015, 50001:2011, OHSMS 45001:2018, BIFMA/ BIFMA-E3 & GREENGUARD/ GREEN BUSINESS/ AIOTA(Ergonomically Designed) or equivalent International certification for quoted items. Certificates to be submitted with technical bid, without which their quotation will not be considered.
- xvi. The bidder should have Computerized Numeric Control (CNC) controlled press form brake for sheet metal bending technology for which supporting certificates such as purchase bill/ installation certificates should be provided with technical bid which can be inspected by the Institute prior giving the order.
- xvii. The bidder should have pressing technology (Hot press) to process post lam and post formed profile for furniture panel for which supporting certificates such as purchase bill/installation certificates should be provided with technical bid which can be inspected by the Institute prior giving the order.
- xviii. The bidder is also required to submit performance report(s) from other similar Organizations Credentials: 80% one order, 60% two order & 40% three order of the estimated cost with completion certificate.
- xix. The manufacturer or bidder should be registered under TRADE MARKS ACT by the Govt. of India. Supporting documents should be enclosed by self attested.
- xx. Manufacturer's catalogue/drawings of the items must be provided with the technical bid without which bid will be taken as rejected.
- xxi. 10% of the order value as performance security deposit to be submitted to the Bose Institute in the form of Bank Guarantee/Demand Draft within 15 days from the date of issuance of the order. In case of non submission of bank guarantee an amount of 10% of the order value will be deducted from the bill value

and will be kept hold up to warranty period of 01 year plus sixty days from the date of completion of the work.

4. <u>Technical Specification:</u>

i) Classroom continuous Desk:

Made of by MS ERW tube as per IS 7138 of 90 mm (W) hollow pipe for all the metal structure except modesty structure will be 36 X 36 mm MS ERW pipe. All metal part will be powder coated paint

Finish of 50 micron thick conforming to IS: 13871 after zinc phosphate for antirust treatment.

Desk will be made by 18 mm thick BWR ply pasted with hot glue machine by 1 mm. thick laminates of Green/ Merino; all exposed edges should be lip with 2 mm thick PVC edge band of (Rehau) make. Entire desk will be grouting by Anchor fastener with care on the floor.

Sizes & laminates color of the entire sets will be as per drawing/ design & as per the engineer in charge.

ii) Class room fixed chair with soft padded arm rest: Fully upholstered foam leatherette /cushions provide comfort for long periods of sitting. Moves smoothly over carpet to avoid snags. Curved arms easily clear desk and table edges. Polished tubular steel frame (25mm dia X 1.2mm thick) for heavy duty strength Scratch resistant black powder coat finish. Dimensions: Seat Size: 20"W x 21"D; Back Size: 19"W x 13"H; Seat Height: 18"H.

iii) DIAS: Made of by 18mm thick BWR grade plywood mounted on 270 mm height & sufficient vertical & horizontal wooden plywood support of 36mm thick under the base of the Dias. Complete with 2 mm thick vinyl flooring pvc mat of desired shade as per the Engineer in charge.

iv) Ceramic writing cum projection board: Ceramic steel surface white matt on steel surface & chrome plated corners. Thickness of the surface sheet is 0.56 mm is non pores and attracts magnets. Totally scratch proof surface having abrasion resistance, shock proof, chemical resistance, fire, water etc. Ceramic surface pleasures silky smooth writing & semi matte surface can be used as projection screen.

v) Projector System 3LCD technology: EPSON/SONY/BENQ or equivalent make projector of 3700 lumen having LAN port available features. Complete supply, fitting/fixing.




