	1	Registration of Vendors: Any vendor willing to take part in the process of e-Tendering will have to enroll and get registered in the Central Public Procurement (CPP) Portal, NIC, GOI through logging on to http://eprocure.gov.in/eprocure/app and the vendor is to click on the link for e-Tendering site as given on the above.
•	2	Digital Signature certificate (DSC): Each vendor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders as applicable from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.
	3	Submission of Tenders : Tenders are to be submitted through online in two folders at a time for each bid, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The uploaded documents are to be virus scanned and duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

- b. This file must be downloaded and opened with MS-Excel. The rate being quoted by the bidder must be entered in the space marked for this purpose in the file. **Quoted rate** will be encrypted under BOQ. **In case quoting any rate in Tender Form, the tender is liable to be summarily rejected**.
- c. All fields in the BOQ file other than those allocated for the name of the bidder and the rate(s) being quoted are non-editable.
- d. The BOQ file must be saved after this and should be uploaded using digital signature.
- e. Bidders are requested not to put any percentage (%) in any column of the BOQ.

7. Earnest Money Deposit:

Demand draft / Bankers cheque / Bank Guarantee / Insurance security bond / FDR towards Earnest Money (EMD) as prescribed in the NIT should in favour of "Bose Institute" payable at Kolkata alongwith a covering letter stating the bank details for releasing the said EMD online by the Institute, as per norms to be submitted to the Purchase Section

- 1. Tender Evaluation Committee (TEC): Evaluation Committee constituted as per Order of the competent authority of Bose Institute, Kolkata.
- 2. Opening & evaluation of tender: If any vendor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished and uploaded in the portal as PDF file.
- 3. Bidders or their representative may wish to be present during tender opening, if they so desire
- 4. Cover (folder) for Statutory Documents (Ref. Sl. No. 4) will be opened first and if found in order, cover (folder) for Sl. No. 5 & 7 will be opened. If there is any deficiency in the Statutory Documents the bid will summarily be rejected.
- 5. Decrypted (transformed into readable formats) documents of the statutory cover will be downloaded & handed over to the Tender Evaluation Committee.
- 6. Pursuant to scrutiny & decision of the Tender Evaluation Committee, the summary list of eligible bidders will be uploaded in the web portals.
- 7. During evaluation the committee may summon of the bidders & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

8. **Financial Proposal:**

- a). The vendor is required to quote the rate online in the designated field marked for quoting rate in the BOQ. For optional items as mentioned in the specifications may be quoted separately in the additional sheet as enclosed in the Financial Cover.
- b). Only downloaded copies of the above documents are to be uploaded upon virus scanning & Digitally Signed by the vendor.
- c). Penalty for suppression / distortion of facts:

If any bidder fails to produce the original hard copies of the documents on demand of the Tender Evaluation Committee within a specified time frame, or if any discrepancy is found between the hard and soft copies that amounts to material deviation, the tender inviting authority may treat such a case as submission of false documents by the bidder and action may be referred to the appropriate authority for prosecution as per relevant IT Act.

Scope of Work

- The bidder is required to supply, install and commission the CCTV System at Unified Academic Campus, Bose Institute as per the specifications and conditions specified in the different parts of this Tender document.
- The bidders are advised to visit the above mentioned sites before quoting bid in the tender.
- The successful bidder shall give comprehensive hands on Training to the concerned persons as identified by the institute on operations, preventive maintenance, recording and retrieval of the CCTV recordings etc..
- The successful bidder shall carry out the work strictly as per specifications mentioned in various sections of this tender document to the satisfaction of the indenting department.
- Workmanship and material used should be of the ISI quality.
- Bids shall be considered only in those cases where the bidder has quoted for the entire scope of the work.
- The Video management software should include admin management Module. User Right access for live viewing of different Camera, Deletion of data etc. or storage access permission. Multiple user view over LAN network.
- Supply, installation & commissioning of Networkable Digital Video Recorder (NVR) 16 Channel with HDD to store 30 days backup SD recording, along with Monitor for live monitoring.
- Supply, installation & commissioning of live monitoring device with 22'
 FHD Monitor (Installation to be done in Security Room beside main entrance gate of Institute)
- Powering on equipment after ensuring correctness of terminations, interfaces and power supply and making the system ready for testing and commissioning.



- Testing of IP CCTV after laying, terminations and ferruling at both the ends. All testing tools and instruments shall be brought by the bidder and taken back after the testing.
- Configuration of the equipment as per the requirements of Bose Institute including Network segmentation and Monitoring
- Onsite warranty for all Networking Equipment's delivered for one year

The Purchaser shall notify the Supplier in writing in a timely manner of the identity of any representatives retained for these purposes.
- Should any inspected or tested Goods fail to conform to the specifications, the Purchaser may reject the goods and the Supplier shall either replace the rejected Goods or make alterations necessary to meet specification requirements free of cost to the Purchaser.
- The Purchaser's right to inspect, test and, where necessary, reject the Goods after the Goods' arrival at Project Site shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by the Purchaser or its representative prior to the Goods shipment.

General Technical Requirements

1	All components such as switches, patch cords, IP CCTV Cameras, Fibers, CAT-6 cables, cable managers, I/O box, Rack etc. offered shall be of the standard make and as per the specifications given in this tender document.
2	Equipment furnished shall be complete in every respect with all mountings, fittings, fixtures and standard accessories normally provided with such equipment and/or needed for erection, completion and safe operation of the equipment's as required by applicable codes though they may not have been specifically detailed in the technical specification, unless included in the list of exclusions.
3	The methodology of cabling an installation work, to be adopted, has to ensure minimum damage to the existing finish and no loss to the aesthetic beauty of the renovated floors. Any damage to the existing flooring/ walls/paint etc. shall be made good by the Contractor. It is advised that tenderer should visit site before submitting the tender to get apprised about the site conditions.
4	The Bidder shall be responsible for providing all materials, equipment's, and services, specified or otherwise, which are required to fulfill the intent of ensuring operability, maintainability, and reliability of the complete equipment covered under this specification within his quoted price. This work shall be in compliance with all applicable standards, statutory regulations and safety requirements in force of the date of award of this contract.
5	The bidder shall also be responsible for deputing qualified personnel for installation, testing, commissioning and other services under his scope of work as per this specification. All required tools and tackles for completing the scope of work as per the specification is also the responsibility of the bidder.
6	The bidders proposal shall include the list of tools (such as; crimping tool, Krone punch tool) and accessories which shall be furnished with the equipment. These are to be clearly brought out with itemized price in the bid. However, the prices of these special tools and tackles shall be included in the lump sum bid price and would be considered for the bid evaluation.
7	The exact seating of equipment's and cable routing shall be determined by the contractor in consultation with Bose Institute. The contractor shall prepare his proposed cable routing diagram and estimate the quantities for cable.
8	The equipment's to be supplied shall operate without any deviation in quality or degradation of system performance and all the parameters detailed in these specifications shall be guaranteed over the following environmental conditions. Operating Temperature: 0o C to 450 C Humidity: 95% RH (non-condensing).
